"The Committee considered the report of the UGC's Expert Committee, AICTE Expert Committee and compliance submitted by the University in respect of these reports.


The Committee accepted the compliance submitted by the University in respect of the observations/suggestions given by the UGC's Expert Committee/AICTE Expert Committee.


The University is advised to get NAAC accreditation at the earliest.
